Vom Ron German Shepherds agrees to sell the above identified dog to Purchaser and stipulates as follows:

- 1) He has received the following vaccinations. Parvo, distemper, hepatitis, and parainfluenza. Any pup purchased before 12 weeks old it is the responsibility of the owner to vaccinate at these exact intervals and NOT expose the puppy to areas where other dogs visit, excluding your home and your own dogs until 16 weeks old and fully vaccinated. Failure to do so will put the pup's health at risk and the health portion of the contract will be null and void. This will be one of a series of three given at 8 weeks, 12 weeks and 16 weeks, followed by a booster at 12 months. At 16 weeks he should also have a rabies vaccination. This is the current AVMA recommended protocol.
- 2) Should the dog develop crippling hip dysplasia and/ or receive an OFA rating of severe then Vom Ron will replace the dog with one of the same quality as soon as one becomes available, after proof of spaying or neutering of the affected dog. Purchaser is responsible for all transportation costs for the replacement dog, if any. Replacement will be available only if the dog is aged 28 months or less at the time of diagnosis, has not been bred, and if the purchaser can provide substantial evidence that they have followed the dietary program recommended by Vom Ron and provided to the purchaser in documentation accompanying the dog. This diet should be substantially similar to the

one we recommend. Sufficient exercise is mandatory. May keep the dog once it is spayed.

- 3) Blackwood 3000 Lamb & Rice plus 1/3 of the diet any raw red meat, no fowl. Raw hamburger, raw stew meat, raw venison, etc. No canned food of any sort. Big, raw beef bones. Dry food must not contain corn, corn meal, or corn gluten, soy, wheat gluten, or animal digest. Clean, fresh water available at all times. Big beef bones only, no rawhide, ropes, tennis balls, etc.
- 4) Vom Ron does not assume responsibility for any veterinary bills or any other expense incurred by purchaser on behalf of the dog, after the dog has left Vom Ron.
- 5) American Kennel Club registration papers will be delivered upon receipt of full payment and signed contract, unless said papers are pending with AKC. In that case registration papers will be mail immediately upon receipt.
- 6) If purchaser does not want to keep the dog for any reason, dog is to be returned to Vom Ron with signed registration papers. **UNDER NO CIRCUMSTANCES IF THIS DOG EVER TO BE PUT INTA A SHELTER, RESCUE, SOLD FOR RESEARCH OR GIVEN AWAY. IF YOU, AS THE PURCHASER, CANNOT KEEP THE DOG IT IS TO BE RETURNED TO VOM RON.**
- 7) We reserve the right to refuse to sell any dog to any person, for whatever reason.
